Over the past year, Good Samaritan's Treatment Program provided more than 300 hours of therapy to help youth in foster care heal from trauma. As the region's leader in serving youth with problematic sexual behaviors, the program helps young people overcome their past experiences and learn to build healthy relationships.

Good Samaritan also operates the largest Transitional Living Program in Missouri, serving one-third of all transitional living youth statewide. In 2025, every eligible young person in our care graduated high school or earned their GED. Our Transitional Living Apartment Program additionally provided stable housing and support for 36 youth preparing to age out of foster care.
