## GOOD SAMARITAN BOYS RANCH CLIENT RIGHTS

While in residence at GSBR, you have the following Rights. All Rights fall within the limitations of the rules and expectations of GSBR and its specific programs.

- 1. The Right to an explanation of services provided, GSBR responsibilities, and expectations and rules for residents.
- 2. The Right to three nutritious meals and snacks daily.
- 3. The Right to adequate clothing.
- 4. The Right to be free from exploitation in employment.
- 5. The Right to an adequate night's sleep.
- 6. The Right to a daily bath or shower.
- 7. The Right to be from abuse or malnutrition.
- 8. The Right to confidentiality.
- 9. The Right to medical treatment, if needed.
- 10. The Right to be involved in partnership with GSBR staff in developing a plan for services or treatment and all review/updates of that plan.
- 11. The Right to family contact, within the limitations of the Individual Treatment Plan.
- 12. The Right to an education.
- 13. The Right to access a telephone within the program guidelines.
- 14. The Right to leisure and recreation time daily within the program guidelines.
- 15. The Right to receive and send mail within the program guidelines.
- 16. The Right to keep personal property and to have appropriate privacy within the program guidelines.
- 17. The Right to refuse treatment or medication and be fully informed as to the potential consequences of refusing them.
- **18.** The Right to request removal from the program.
- 19. The Right to receive fair treatment without discrimination due to race, religion, sexual orientation, age, gender, or handicapping condition.
- 20. The Right to make a written complaint (grievance) if you believe that your rights have been violated, and to receive a response in a timely manner per policy.
- 21. The Right to a safe, sanitary, and humane living environment.
- 22. The Right to communicate freely with your attorney or the courts.
- 23. YOU HAVE THE FOLLOWING RIGHTS SUBJECT TO LIMITATIONS FOR PURPOSES OF TREATMENT:
  - a to be made aware of your treatment plan and goals
  - b to the least restrictive conditions necessary to achieve the purposes of treatment
  - C to be informed of your condition and progress
  - d to have your treatment record and all information kept confidential
  - e to have the opportunity to meet with members of your treatment team
  - f not to be subjected to unnecessary procedures, whether diagnostic or therapeutic
  - g the Right to receive spiritual care (excluding satanic or other cult—like involvement).

## 24. OTHER WRITTEN RIGHTS AND RESPONSIBILITIES:

- a to receive services 24 hours a day, seven days a week
- b to understand that any behaviors and/or other factors displayed by any resident which are determined by the treatment team to be detrimental to any resident may be grounds for discharge or termination from the program.
- C for the person served, their families, and/or legal guardians to participate in decisions regarding the services provided,

These treatment, personal and communication rights may be limited for good cause by your treatment team, Any such limitation must be recorded in written form in your treatment record with an explanation of the reasons to such limitation.
